ORDER:

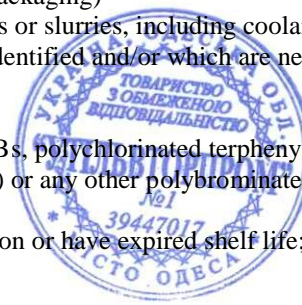
